**IMPLEMENTATION OF TARIFF ORDER NO. 40/2015-16 dated 08.12.2015**  
**ISSUED ON 10.12.2015 WITH REFERENCE TO IGI AIRPORT**

The Hon'ble Supreme Court, while vacating the stay given by Hon'ble Delhi High Court has directed that the Tariff Order No. 40/2015-16 dated 08.12.2015 shall be implemented forthwith, which was further notified by AIC 13/2017 dated 07.07.2017. Thus, all the passengers who are bound to travel beyond 07.07.2017 will be eligible for paying airport charges as per AERA's Order No. 40/2015-16.

2. Accordingly, Airports Economic Regulatory Authority (AERA), vide letter no. AERA/20010/MoCA-Reference/2011-12/Vol-II/2012 dated 10.07.2017 (Annexure) has decided for refund of the excess UDF collected from passengers travelling after 07.07.2017 from/to IGI airport, Delhi. The domestic passengers may be allowed 45 days' time to claim the refund from the airlines and the international travellers may be given 60 days' time. After the due date, the balance unclaimed amount, duly verified by chartered accountant, may be remitted to DIAL by airlines which shall be adjusted while determining the aeronautical tariff of IGI Airport for the next control period. Further, in respect of the passengers who booked the ticket on or before 07.07.2017 but are yet to commence the travel, Airlines shall refund the excess amount, if any, to the passengers without waiting for such claim from the passenger.

3. Therefore, Airlines shall refund the amount collected from the passengers who will travel/have already travelled after 24 hours IST of 07.07.2017 as per the procedure stipulated by AERA in para 2 above.



**Sir,**

I am directed to refer to AERA letter No. AERA/20010/MoCA-Reference/2011-12/Vol-II dated 06.07.2017 regarding the above cited subject and subsequent implementation of above referred tariff order vide AIC No. 13/2017 dated 07.07.2017.

In this regard the airlines may be instructed to refund the excess UDF collected from passengers travelling after 07.07.2017 from/to IGI airport, Delhi. The domestic passengers may be allowed 45 days' time to claim the refund from the airlines and the international travellers may be given 60 days' time. After the due date, the balance unclaimed amount, duly verified by chartered accountant, may be remitted to DIAL by airlines which shall be adjusted while determining the aeronautical tariff of IGI airport for next control period.
