Madam/Sir,

As a precursor to Vigilance Awareness Week- 2023, the Commission has decided to take up certain focus areas. One of the focus areas would be capacity building. It has been decided that a campaign for conducting trainings under following subjects would be carried out:

- (I) 3-day offline training for IOs/POs
- (II) 3-day offline training on Public Procurement
- (III) 2-day offline training on Preventive Vigilance

2.
