Sir,

Reference is invited to the Casual Workers Absorption Schemes 1990 and 1995 of CSIR. Extracts of the general conditions at para 6 is given below.

"Open recruitment for filling up entry level vacancies in Group C & D shall be banned till casual workers already engaged but satisfying the terms and conditions for regularization, are fully absorbed".

Subsequently, vide CSIR letter no. 2(28)/91-E.II dated 20.05.1998 it was stated that the vacancies should be notified to all the Labs/Instt. through the letters addressed to all the directors by registered post requesting them to bring the same to the notice of all the eligible casual workers and to send back the application received in response from the concerned casual workers. This was followed by another circular vide CSIR letter no. 4-2(28)/91-E.II dated 06.08.2002 with further clarifications on the issue.

In a bid to review the above instructions, it is desirable to collect information regarding identified casual workers due to be regularized as on date. Hence, it is requested that the requisite information, duly filled in the prescribed format be provided to this office latest by 17th April, 2023.
