Dear Directors / Heads,

The policy landscape of Stores & Purchase has undergone fundamental changes, especially in the last few years. Besides, the major nodal Ministries viz., DOE/MOF, DPIIT, GeM (Ministry of Commerce), and MSME, new guidelines continue to be issued virtually by every Ministry of the Govt. of India having bearing on Procurement & Stores. Be it a ban on single-use plastic (SUP), safe disposal of batteries, e-waste, radioactive wastes, guidelines on radiation-generating equipment, levy of TDS on GST or the withdrawal of GST concession to R&D organizations, they all have a direct or indirect bearing on procurement. Likewise, the old rules and procedures of CSIR adopted and followed at different points of time are also often required for reference. However, locating applicable guidelines/ circulars has always been a challenge.

- 2. I am pleased to inform you that the Stores & Purchase Division of CSIR Headquarters has made efforts to collate most of these basic rules and procedures relating to Stores & Purchase at one place on the CSIR website under the template "Stores-Purchase Universe". It can be viewed at the link https://www.csir.res.in/stores-purchase-universe.
- 3. While all effort has been made to curate the repository of CSIR Circulars/Guidelines and Websites of key Ministries issuing policy guidelines on Stores & Purchases, it is by no means exhaustive. Yet, this initiative is expected to give a big relief to the practitioners of Store & Purchase in CSIR. They are, however, advised to keep themselves abreast of all the latest policy changes/prescriptions relating to Stores & Purchase issued by various Agencies/ Departments of the Government.
- 4. It is reiterated that insofar as Store & Purchase is concerned, CSIR is completely in alignment with GFR & DFPR and is subjected to all the guidelines/ instructions issued by various Departments/ Agencies of Govt. of India unless CSIR has consciously chosen to diverge from the same with due prior approval of the Government.
