Except in the case of emergency, permission letter for extending credit facility have to be issued by the laboratories/institutes to the concerned hospital/institute in each case. In the case of emergency (duly certified by the treating doctor), no such credit letter would be required.

The hospitals/institutes concerned will submit their bills/reimbursement claims alongwith claim forms (duly signed by the employee/pensioner or family pensioner) directly to the concerned laboratory/institute of CSIR.

The Delhi based laboratories/ institutes of CSIR will ensure that bills/reimbursement claims of above hospitals/institutes are cleared within the time as stipulated under Memorandum of Agreements (MoAs) signed by CSIR Headquarters.
