**9.** The promotees will be on probation for a period of one year from the date of taking over charge of the post. The probationary period may be extended or curtailed at the discretion of the competent authority.

**10.** The pay of the promotees will be fixed under the normal rules. However, they will have the option, to be exercised within one month from the date of taking over charge of the post, for fixation of pay in the new post with effect from the date of promotion to the new post or with effect from the date of increment in the lower post, in terms of the extant provisions of FR-22.



**11.** All the promotees may join their promoted posts/new places of postings immediately but in any case within one month from the date of issue of this OM.

**12.** In case of Charge sheet, criminal case and/or suspension against any of the above officers before their joining against promoted post, his/her DPC recommendations shall be deemed to be under sealed cover as per DOPT OM dated 14.09.1992.

**13.** The appointment on promotion will be subject to various terms and conditions mentioned in aforesaid CSIR OM Number 3-3(b)/2023-E.I dated 27.04.2023.
