MONITORING THE IMPLEMENTATION OF ESM RESERVATION

My Dear Do W Kalaiselvi

- Cabinet secretariat has mandated Department of Ex-Servicemen Welfare (DESW) Ministry of Defence to collect and compile the data/ information for implementation of reservation policy for ESM in CCS&Ps, PSBs, CPSEs/ CPSUs, CAPFs etc and other Recruiting Agencies. Reservation Monttering Cell (RMC) under the aegis of Directorate General Recettlement (DGR) has been created to monitor the implementation of ESM Reservation Policy and assignated as the nodal agency on behalf of DESW to collect and compile the required data for assessment and formulation of various schemes for welfare of Ex-Servicemen (ESM) Community.
- in this connection, I would like to invite your attention towards the DoP&T OM No. 36034/3/2013-Estt. (Res.) dated 25th February, 2014 regarding "lesue of Compendium of instructions on reservation for Ex-Servicemen" and especially towards Chapter 04, 07 & 12 of the compendium document pertaining to calculation of Vacancies as per applicable ESM reservation, Intimation of Vacancies for prior information of ESM and Periodic Returns about the utilisation of reserved vacancies for Ex-Servicemen.
- I would also like to apprise you with DoP&T OM No. 36035/8/92 -Estt. (SCT) dated 10th Nov 1994 regarding appointment of Lieison Officers for monitoring the matters relating to Ex-Servicemen reservation. This has jurther been reiterated vide DoP&T OM No. 38034/2/2017-Estt. (Res) dated 31st Dec 2021. I am thank-full that work related to nomination of dedicated Liaison Officers (ESM) has been completed by most of the Min/ Deptts but there are Min/ Deptis which are still in the process of completing the task in this regard.

- Govt jobs is a very good option for ESM for permanent resettlement in civil life post their retirement from active service up to the superannuation age as admissible for Civilian counterparts with all other benefits as admissible to other Govt employees. Resettlement through Govt job provides stability to ESM which is of paramount importance for fulfilling their social and form. social and family responsibilities due to their early retirement from the Armed Forces. Nonallocation of ESM Reservation or lack in implementation of ESM Reservation is hampering expectation of ESM and thereby defeating the purpose for which reservation has been provided. It is seen from the Half-Yearly Reports being received at this office that in spite of clear policy of ESM reservation and its implementation, there is a big short fall in filling-up the prescribed quotas by attributing to one or the other reasons. The matter in regard to utilization of ESM reservation is being raised in the Parliament Sessions and had become very significant in the light of newly introduced "Agni-Path" scheme for enrolment of soldiers in three-services.
- In this regard, may I look forward for a positive response thereby contributing towards our endeavour of resettlement of our ESM suitably and utilizing their skills and potential for nations' growth, as per the vision imagined by our Hon' ble Prime Minister by drawing attention on the following aspects: -
 - (a) Identification of ESM vacancies as per Gol Rules/ Directives/ Guldelines;
 - (b) Prior intimation of ESM vacancies for publication on DGR website for wider circulation amongst ESM community and ~
 - (c) Submission of Half-Yearly Report (hard copy & soft copy in Excel format) as per prescribed time-lines duly compiled and vetted by the Liaison Officer (ESM Reservation) In respect of your Ministry, Deptts and CPSEs/ CPSUs etc."
- I am sanguine that together we can achieve the vision set by our Hon' ble Prime Minister for "Employment for Ali".
