OFFICE MEMORANDUM

Subject:- Filling up of vacancies in a mission mode - regarding.

Government has decided to fill up vacancies in various Ministries/Departments in a Mission Mode. Accordingly, a dedicated online portal viz. "Vacancy Status Portal" has been put in place for reporting and monitoring the progress in filling up of vacancies.

- 2. The status of progress is being reviewed at the highest level regularly. Based on a recent review, it has been decided that various Ministries/Departments may take the following actions to ensure filling up of all vacancies in a time bound manner:
 - i. Ministries/Departments, which are yet to upload data on the Vacancy Status Portal may do so without any further delay; latest by 15.09.2022.
 - ii. Month-wise number of vacancies under Direct Recruitment category, for which offer letters/appointment letters are ready to be issued, may be indicated on the portal for which necessary provision will be made available on the portal by 15.09.2022. Such offer letters/appointment letters will be consolidated for Unified Integrated Digital Issuance.
 - iii. Proposal for revival of posts falling under "Deemed Abolished" category may be submitted for approval of Department of Expenditure, wherever required, before 15.09.2022.
 - iv. Direct Recruitment vacancies resulting from promotions may be assessed and indent for such vacancies may be placed with the relevant Recruitment Agencies latest by 20.09.2022.
 - v. Considering the time taken for completion of the entire recruitment process, Direct Recruitment vacancies likely to arise on account of retirements during 2023-24 may be anticipated, in consultation with Department of Expenditure, so that the indent for such vacancies could be placed with the relevant Recruitment Agencies in the ongoing recruitment cycle.
 - vi. Vacancies in Public Sector Undertakings, Autonomous Bodies, Institutions, etc. may also be taken into consideration and information on such vacancies may also be uploaded on the "Vacancy Status Portal".
- 3. Secretaries of all Ministries/Departments are requested to review the action taken in this regard on weekly basis and ensure timely updation of data on the "Vacancy Status Portal".

Collective Digital issuance of Offer/Appointment letters - reg

With reference to the subject mentioned above, Cabinet Secretary in his D.O. No. 1/13/1/2022-Cab dated 14/9/2022 referring to the meeting of Council of Ministers held on 7th September 2022, requested all the Ministries/ Departments to finalize the calendar for appointments by direct recruitment and filling up of vacancies consequent to promotions and retirements in consultation with DOPT to further compress the time frame for completion of recruitment process. In this regard, numbers of meetings were taken by the Secretary and the Additional Secretary, DOPT with Ministries/ Departments.

- 2. The Ministries/ Departments were asked to provide the details on the numbers for which offer of appointment/appointment letters are to be issued in the coming months by email by 15th September 2022. However, only a few Ministries responded that too with incomplete figures.
- 3. It is informed that a provision to (i) update the bi-monthly target and (ii) updation of details by the PSUs/Attached /Subordinate and other offices on the "Vacancy Status Portal' has already been enabled. The user ID and Password for the PSUs/Attached and Subordinate offices are made available in the dashboard of the Administrative Ministry.
- 4. In view of above, all the Ministries/ Department are requested to kindly update the targets on the web portal urgently. Also the Administrative Ministries/ Departments are requested to share the user id and password allocated to PSUs/ Autonomous bodies under their administrative control to enable the PSUs /Attached/Subordinate offices to update the details on the Vacancy Status Portal.
