Free Trade Agreement (FTA) is under consideration with UK, EU, Australia Israel and Canada. In this connection there was a stakeholders' meeting on 1st July, 2022 organized by Department of Commerce, Ministry of Commerce & Industry. The proposal under consideration under the FTA is on the issue of Market Access of Goods and Services on the Government Procurement.

- 2. Specific response is required on the following issues:
 - a) Difficulties faced by Indian Suppliers pertaining to our Ministry/Department or attached subordinate offices/PSUs in government tenders issued by Govt. of UK/EU/Australia/Canada.
 - b) Whether the Ministry/Department or attached subordinate offices/PSU would be agreeable to be included in the market access schedule proposed to be provided to the aforesaid Countries. If not agreeable, the reasons thereof and if only certain products are to be excluded, their HC/CPC codes with reasons.
- 3. In order to furnish a specific response to (2 (a)) as above, Labs/Instts./Units are requested to provide information as per attached format with regard to Indian Manufacturers of R&D equipment and R&D consumables.

- 4. Further, Labs/Instts./Units are requested to provide their opinion on 2 (b) as above also.
- 5. Your inputs and report as requested in (3) and (4) required to be submitted on or before **08.07.2022 by 4.00 P M positively.** Reports already submitted by the Labs/Instts./Units need not submit again. However, they can provide their inputs for 2(b).
