## Sub: Promotion of Sh. Shailendra Pratap Singh, Deputy Financial Adviser to the Post of Senior Deputy Financial Adviser in Pay Level – 13 (₹123100-215900) - reg.

<u>1.</u> Panel for promotion to the posts of Sr. Dy. FA/Sr. COFA in Pay Level – 13 (₹123100-215900) for the Vacancy Year 2021 was notified vide OM of even number dated 30.12.2021 inter alia mentioning that recommendations of DPC was kept in sealed cover in r/o one Officer.

<u>2.</u> As per DG, CSIR Order No. 17-01/SP/CSIR/HR-III/2023 dated 07.03.2023, the Articles of Charges in respect of Sh. Shailendra Pratap Singh, Dy. FA have been dropped. FA/ Sr. COFA in Pay Level – 13 (123100-215900). In case Sh.
