Sub: Remittance of Pending NPS Accumulation of CSIR Employees/Ex-Employees reg.

Dear Madam / Sir,

Please refer to this office letter No-34-2(5)/NPS/2015-16 Dated 01.08.2022 on the above Subject. As you are aware that NPS was implemented in CSIR w.e.f. 01.01.2004. CSIR was appointed as Pension Fund Manager vide CSIR letter no. 32-2(5)/NPS-2004 dated 18.05.2004 till the appointment of regular Central Record Keeping Agency. Accordingly, it was proposed that such amount representing the Contribution made by the council servants and matching contribution made by the council will be kept in a separate account at CSIR.

However, w.e.f. 01.04.2010 the NSDL was appointed as Central Record Keeping Agency and all CSIR labs/Instts/Units were directed to remit the accumulation of each NPS subscriber to NSDL as per their record by following the laid down procedure. The labs/Instts/units remitted the amount to NSDL and recouped the same from CSIR Hq. However, in some cases due to absence of PRAN number/whereabouts of the individuals, the NPS amount is still pending as unclaimed at CSIR Hq.

In this regard, reference is invited to CSIR letter No-34-2(5)/NPS/2015-16 dated 13.07.2015, 04.11.2015,16.02.2016 and 01.08.2022 (copies attached) in which it was requested to take necessary action for the identification of unclaimed amount of concerned NPS subscriber who have left the CSIR services and recoup their NPS amount from Fund Section, CSIR Hq.

CAG Audit has pointed out that unclaimed funds of NPS subscriber are awaiting adjustment due to non-making of vigorous efforts to settle the same leading to irregular parking of funds.

In view of above, it is again requested to provide a list of NPS subscriber along with their unclaimed amount in the provided proforma as under: -

Dear Sir,

I am to inform that NPS accumulations for the Period 01.01.2004 to 31.03.2020 in respect of employees who have left CSIR service are lying with CSIR Fund Section because of non avability of their PRAN. Due to non avability of PRAN or other reasons this amount has not been remitted to CSIR Institutes till date. In this regard reference is invited of CSIR letter No-34-2(5)/NPS/2015-16 dated 13.07.2015,04.11.2015 and 16.02.2016(copies attached) in which it was requested to take necessary action for the identification of amount of CSIR employees who have left the CSIR services and for recoupment of their amount from Fund Section, CSIR Hq. CAG Audit which is presently conducting transaction audit of CSIR has also pointed out non remittance of Pending NPS accumulations and requested to take necessary action for Payment/transfer of these amounts to respective Labs so that same may be remitted to NSDL.

In view of above necessary steps may please be taken at Lab level to Contact such ex-employees who left CSIR before allotment of PRAN through their official records like service book and Personal files and necessary correspondence may be made with them for remittance of their NPS amount to NSDL at the earliest.

In this regard it is also requested to provide the list of these employees with their amount which is not yet remitted to NSDL and latest proof of correspondence made with them within one month from issue of this letter to enable this section to apprise the CAG Audit in this regard in the given format:-

Subject: Allotment of PRAN to ex-employees.

Sir,

It has been observed that NPS accumulations in t/o employees who have left CSIR, is lying with the CSIR labs/instts because of non-availability of PRAN. In this regard, discussion was held with Pension Fund Regulatory & Development Authority (PFRDA). It was suggested by PFRDA that the exemployees, who had not been allotted PRAN, may be suggested to obtain PRAN through 'All Citizen Model' of NPS and communicate the PRAN so allotted to their respective CSIR labs/instts so that the accumulated amount may be processed for remittance.

In the case of employees who have joined another organization or have been transferred to any other CSIR lab/instt, the PRAN may be obtained from the employee and the accumulated NPS contribution remitted to NSDL.
