Sub: Permission to fill up of Group IV posts in Labs / Institutes – regarding.

Sir / Madam,

Kindly refer to CSIR Circular No. 5-1(14)/2008-PD dated 06.2.2017 on the subject of permission of Ministry of Finance to fill up the vacant posts within the sanctioned strength. As indicated in the said Circular, the vacant posts in S&T cadre within the existing sanctioned strength may now be filled up as per rules.

2. It may be recalled that earlier CSIR H'qrs. had issued an OM No. 5-1(14)/2008-PD dated 26.11.2013 indicating that "DG, CSIR had directed that appointment to S&T posts of CSIR may be done within the overall ceiling during the austerity period and will be controlled by the Recruitment and Assessment Board (RAB) of CSIR". As per this Circular dated 26.11.2013, RAB was to limit the posts to be filled to the vacancies that have arisen during the last one year as per the instructions on austerity measures issued by Govt. of India, Ministry of Finance, Department of Expenditure OM No. 7(2)/E.Coord/2013 dated 18.9.2013 & 29.10.2014. Consequently, the proposals for filling up of vacant posts/beginning the process of recruitment in Labs/Instts. were examined by RAB.

3. Now, in the context of CSIR Circular No. 5-1(14)/2008-PD dated 06.2.2017, it is hereby clarified that even though the proposals of the Labs/Instts. for filling up of vacant posts need no longer be examined in accordance with the guidelines for implementation of austerity measures, they may continue to be forwarded to RAB in compliance with Rules 6.5 of CSRAP Rules, 2001, which provide that "Vacancies for which Selections are required to be made by the Board shall be decided by the Labs/Instts/CSIR H'qrs with the approval of RC of the Lab or DG, CSIR, as the case may be".

4. Therefore, all Labs/Instts/ CSIR H'qrs. may continue to send their proposals for filling up of vacant posts in scientific cadre (Group IV) within the overall sanctioned strength of Group IV posts in their respective Lab/Instt./ H'qrs.

5. This issues with the approval of the Competent Authority.
