
The above promotees will be on probation for a period of one year from the date of taking over charge of the post. The probationary period may be extended or curtailed at the discretion of the competent authority.

The pay of the promotees will be fixed under the normal rules. However, they shall have the option, to be exercised within one month from the date of taking over charge of the post, for fixation of pay with effect from the date of appointment to the new post or with effect from the date of increment in the lower post, under the provisions of FR - 22. The promotees will be entitled to TA / DA joining time, joining time pay etc as admissible under the rules.
