Counting of Special Pay of Rs. 2000/- (before 2006) and Rs. 4000/- (after 2006) for

the purpose of reckoning of Pension / Pensionary Benefits to the retired Scientists

of CSIR- reg.

Sir/Madam,

I am directed to state that the matter of counting of Special Pay of Rs. 2000 / Rs. 4000 for the purpose of reckoning of pensionary benefits to all the eligible retired Scientist 'G' Group IV (6) / Chief Scientist [Pay scale of Rs. 18,400-22,400 (pre-revised 5th CPC) or PB-4, GP-Rs. 10,000 (pre-revised 6th CPC)] who had drawn such Special Pay, has been under consideration. Now, the Department of Expenditure, Ministry of Finance, vide ID Note No. 1(20)/EV/2017 dated 17.08.2023, has agreed to consider counting of Special Pay for the purpose of Pensionary benefits and the methodology for fixation of pension is as under:

"Special Pay may not be merged in the last Basic Pay. Once Pension is computed on the basis of last pay drawn, 50% of the quantum of Special Pay as drawn by the employee on the date of retirement (Rs. 2000/- and Rs. 4000/- as the case may be) may be added to the Pension so fixed. In case of revision of Pension after Pay Commission in terms of respective guidelines of DoPPW, the Special Pay will not be taken into consideration. However, once Pension is revised, 50% of the Special Pay as available to the employee on the date of retirement shall be added to such revised Pension."

It is, therefore, requested that the above decision may kindly be brought to the notice of all the concerned in your Lab./Instt. and taking necessary action.
