NOTIFICATION

Sub: Provisional List of shortlisted candidates called for Trade Test against advt. No. R&A/01/2022 for the post of Technical Assistants at CSIR Hqrs. – reg.

This is for information of all concerned that a list of provisionally shortlisted candidates to be called for Trade Test against advertisement No. R&A/01/2022 was notified vide web notification dated 11.07.2023 with stipulation that "representations, if any, of the candidates can be submitted through the Recruitment Portal <https://recruitment.csir.res.in> duly enclosing proof in support of his / her claim, on or before 21.07.2023 (till 17:00 hours)".

2. In response, a total of 55 representations against various post codes under the advertisement were received through the Recruitment Portal i.e. <https://recruitment.csir.res.in> till 21.07.2023 (till 17.00 hrs.) and the same were placed before the Screening Committees for their consideration and recommendations. The Competent Authority has approved the recommendations of the Screening Committee and in light of these recommendations and decisions taken thereon, the representations of candidates for all the post codes stand disposed of accordingly. The disposal of representations is being communicated individually through email to the candidates concerned. The representations received other than through Recruitment Portal have not been considered. **No further representations to this effect will be entertained.** The post code wise list of provisionally shortlisted candidates being called for Trade Test, is enclosed herewith as **Annexure-I to XI.**

3. Venue and dates for conducting the Trade Test for the posts of Technical Assistants notified vide advt. No. R&A/01/2022 is as follows:

5. The candidature of all the shortlisted candidates for Trade Test as mentioned in **Annexure-I to XI** is "**Provisional**" and subject to verification of all the relevant documents / certificates from original, as claimed by the candidates in their application form.

6. Syllabus for the Trade Tests / Written Test is enclosed herewith as **Annexure-XII to XXI**.

7. The call letters along-with detailed information regarding address of venue and other terms and conditions may be downloaded from CSIR Recruitment Portal (i.e. <https://recruitment.csir.res.in>) 10 days before the scheduled date of start of trade test for that particular post code. Candidates are advised to submit the self-attested printout of their applications, submitted online along-with the following enclosures, at the time of reporting for Trade Test, to verify the information furnished in the application:

- (a) Original certificates in support of Date of Birth and Educational qualifications (from SSLC/ Matriculation onwards) along with Mark sheets.
- (b) Original experience certificates, as proof of experience.
- (c) Original Latest/Valid Caste/Community Certificate issued by the Competent Authority in the case of SC, ST, OBC Certificate (non-creamy layer) and EWS candidates in the prescribed format of Government of India.
- (d) Original disability certificate issued by Competent Authority in the form prescribed by the Government of India in case of PwBD candidates.
- (e) In case of persons employed in Government Departments, Autonomous bodies, Public Sector Undertakings, a "**No Objection Certificate**" from the present employer, failing which s/he may not be allowed to appear for the Trade Test.
- (f) Any other original document in support of the claim made in the application, as applicable.

8. Further, if it is found at any stage of the recruitment process that the applicant has furnished any incorrect / false information / certificate/ documents or suppressed any material fact(s) or does not fulfil any of the conditions of eligibility such as essential qualification, prescribed age limit, category etc., for the posts notified vide CSIR Advt. No. R&A/01/2022, the candidature is liable to be cancelled without any further notice. If any of these shortcoming(s) is/ are detected after appointment in CSIR, his/ her services are liable to be summarily terminated. Candidates are, therefore, advised to check carefully and satisfy themselves that they fulfill all conditions as stipulated in the advertisement for the post they have applied for before attending the Trade Test.

9. No TA / DA will be paid by CSIR for the above said Trade Tests. The candidates are advised to make their own arrangements for stay, if required.

10. CSIR reserves to itself the right to not to fill up any or all the posts. In case of insufficient number of candidates for the written test, CSIR in its discretion can take a decision regarding proceeding for the next stage of recruitment process, for the concerned categories. The decision of the Competent Authority of CSIR in all matters related to this recruitment will be final and binding upon all the candidates.
