Sub: Scheme for preparation, maintenance and custody of list of Council servants with doubtful integrity holding equivalent status to that of Gazetted Officers-report for the year ending 31st Dec., 2022.

Sir/Madam,

I am to refer to the Ministry of Home Affairs letter No. 105/1/66-A-AVD, dated 28.10.1969 on the above subject and to state that the list of Council Servants with doubtful integrity holding equivalent status to that of Gazetted Officers is to be forwarded to the CBI for the year 2022. As stipulated in the foresaid letter, the officials who fall under any one of the following categories are to be included in the list.

- Those who are convicted in the Court of Law on charge of integrity or for an offence involving moral turpitude, but on whom in view of exceptional circumstances the penalty other that dismissal, removal, or compulsory retirement is imposed.
- 2) Those who have been awarded a major penalty on charges of lack of integrity or for gross dereliction of duty in protecting the interest of the Govt.(CSIR) although the corrupt motive may not be capable of proof.
- Those against whom major penalty proceedings or Court trial is in progress for alleged acts involving lack of integrity or moral turpitude.
- 4) Those who are prosecuted but acquitted on technical grounds and in whose case on the basis of evidence during the trial there remain a reasonable suspicion against their integrity.

The list prepared on the above lines for the year ending 31^{st} December, 2022 in r/o your Lab/Instt. may be sent to the undersigned by 25.01.2023 positively.
