महोदया / महोदय / Madam / Sir,

You are aware that the CSIR has engaged Dr. P Palaniappan, IAS (Retd) and Dr. Rajan S Katoch, IAS (Retd) as IEMs for CSIR on instructions of CVC. Notification to this effect was issued vide referred OM dated 01/02/2022.

2. Meanwhile, CVC has revised the Standard Operating Procedure (SoP) for implementation of IP-IEM Scheme. This has been notified on the CSIR website vide letter dated 12/07/2023. As per Clause 6.0 of the said Revised SOP, the fees per sitting to be paid to the IEMs has been revised and fixed at Rs. 25000/- per sitting. The overall annual ceiling, however, remains unchanged at Rs. 3 Lakhs per calendar year.

3. As before, confirmation from CSIR Hqrs (through email ID spo.hqrs@csir.res.in) is required to be taken to ensure that the overall annual ceiling is not exceeded. DDOs shall not allow any payment without this confirmation from CSIR Hqrs.

You are accordingly requested to bring the above to the notice of all concerned for expeditious processing of the payments to the IEMs as per revised rates/SOP.
