It would be obligatory on the part of the assesses to continue to perform the same duties and /or such other duties as may be assigned to them from time to time.

The pay of the above assesses shall be fixed as per normal rules. However they may be required to exercise option, except in the case of late V.K. Mallick, within one month from the date of issue of this Office Memorandum for fixation of their pay in the higher grade straightway from the date of their assessment/promotion to the next higher grade or from the date of their next increment in the lower grade, under FR 22(1) a (1). Option once exercised shall be final and irrevocable.
