Reference is invited to this office circular letter of even number dated 23.11.2015 whereby, the following approval of DG,CSIR, in his capacity as Chairman, Governing Body CSIR, was communicated to the relaxation of provisions of Rule 6.1.2(ii) CSRAP Rule,2001.

- "2. Under Rule 9 of the CSRAP Rules, 2001, the DG, CSIR in his capacity as Chairman, Governing Body, CSIR has been pleased to accord approval for relaxation of the provisions of the existing Rule 6.1.2(ii) of rules ibid, to the extent that, due to exigency and operational difficulty including acute manpower shortage, if any CSIR Lab./Instt. desires, then such Lab./Instt. may indicate the Grade Pay for any post they are advertising. This relaxation would also be applicable in the case of Labs/Instts. who have already advertised posts specifying the Grade Pay on account of the aforementioned reasons."
