OFFICE MEMORANDUM

Sub: Time bound disposal of complaints received under PIDPI Resolution by the CVOs of the Ministries/Departments of Govt. of India.

As we are aware that the Govt. of India, vide PIDPI Resolution dated 21.04.2004, has authorised the Central Vigilance Commission as the Designated Agency to receive written complaints or disclosure on any allegation of corruption or of misuse of office by an of the Central Government or of any corporation established by or under any Central Act, Government Companies, societies or local authorities owned or controlled by the Central Government. The Commission vide its office order no. 22/4/05 dated 20.04.2005 stipulated the procedures to be followed for handling of complaints received under the said resolution. Subsequently, the Govt. of India vide DoPT notification dated 14.08.2013 brought out an amendment to the PIDPI Resolution 2004 authorising the CVOs of the Ministries/Departments of the Central Govt. to receive whistle blower complaints or disclosures as the Designated Authority. Thereafter, the DoPT vide its OM no. 371/4/2013-AVD-III dated 16.06.2014 has laid down the procedure for handling of complaints or disclosure received by the designated authorities under PIDPI Resolution, 2004.

2. The Commission has observed that during various stages of processing the PIDPI complaints, there is considerable delay on the part of the Ministries/Departments. It is requested that Ministries/Departments may ensure time bound disposal of PIDPI complaints.
