Subject:- Clarification in respect of CSIR letter of even number dated 3.2.2015 and 12.3.15, regarding suspension of business of M/s. Track Cargo Pvt. Ltd. across CSIR.

It is informed that by the orders of competent authority, the business of M/s. Track Cargo Pvt. Ltd., was suspended until further order for indulging in fraudulent practices vide CSIR letter of even number dated 3.2.2015. In response, M/s. Track Cargo Pvt. Ltd. filed a writ petition before Hon. High Court of Delhi seeking relief in this matter. The Hon. Court intervened in the matter and passed an interim order dated 12.2.2015, asking CSIR to maintain status-quo until further orders from the Hon. Court. Respecting the interim orders, the CSIR Hqrs. issued another letter of even number dated 12.3.2015 asking to maintain status quo with regard to any business/agreement with M/s. Track Cargo Pvt. Ltd. till further orders from the Hon. Court. Status quo meant the position existing on 12.2.2015.

The latest position is that the interim orders are still prevailing and the next date of hearing is fixed on 17.01.2017. These orders are applicable to All CSIR National Labs/Instts. On a particular reference regarding the applicability of CSIR letters of even number dated 3.2.15 and 12.2.2015, the matter was referred to Legal Adviser, CSIR for legal advice, wherein LA, CSIR has stated that in a similar case they have communicated the following course of action to CSIR IGIB.

“There should be no objection if IGIB float a fresh tender inter-alia with the terms and conditions in the fresh tender that in case of bidder's black-listing and pending legal issue in respect of any of CSIR Labs./Instts. or any other government funded organisation, the bidders should inform it to IGIB. If there is any pending legal issue, then CSIR-IGIB reserves the right to accept/reject the tender of such bidder”.
