**Sub** Dates of Meetings of DPCs and Tentative Details of Vacancies and Eligibility Lists etc. for Promotion to Group 'A' Common Cadre Posts - 2<sup>nd</sup> /Supplementary DPCs for the Vacancy Year 2015-16 and DPCs for the Vacancy Year 2016-17.

The meetings of DPCs for promotion to various Group 'A' Common Cadre posts for the above Vacancy Years will be convened on 29<sup>th</sup>, 30<sup>th</sup> & 31<sup>st</sup> August, 2016 and on 09<sup>th</sup> September, 2016 at CSIR Hqrs.

In order to have transparency in the process, the following tentative details are notified herewith for information of all concerned:-

1. Details of vacancies of Sr. DS/Sr. COA, DS/COA, US/AO; Dy. FA/COFA, F&AO; COSP & SPO. The exact nos. of vacancies depend upon various factors and, therefore, may vary at the time of holding of DPC.
2. The ZOCs for the posts of DS/COA, US/AO, F&AO and SPO are dependent, inter alia, upon the resultant vacancies. It is presumed that all the vacancies in the higher posts will be filled up and all the resultant vacancies will be available. If this does not happen, the total vacancies and consequently ZOC will get reduced and some of the junior officers in the eligibility lists may not come in the ZOCs.
3. Eligibility Lists and ZOCs have been prepared in accordance with the guidelines contained in DOPT OM Nos. 22011/1/90-Estt(D) dated 12.10.1990 & 22.04.1992.
4. The panels for the posts of DS/COA, Dy. FA/COFA, COSP, US/AO and F&AO will be subject to the outcome of various OAs pending before different benches of the Hon'ble CAT.
5. Officers included in the eligibility lists are advised to ensure that their ACRs/O-APAR folders upto 31.03.2015 are complete in all respects.

Details of Vacancies for 2<sup>nd</sup>/Supplementary DPC for the Vacancy Year 2015-16

**No. of Vacancies available for 2<sup>nd</sup>/Supplementary DPC : 01**

DPC for the post of US/AO was held for total 14 posts (3 backlog + 11 current). Based on the respective backlog vacancies and ratio, breakup of posts amongst SOs (Gen) and PSs was – for Total 14 (8 + 6) and for Current 11 (7 + 4). With the availability of 01 more vacancy, current vacancies would be 12 which when divided in 2:1 ratio will be 8 for SOs and 4 for PSs. This implies only SOs will be considered for 2<sup>nd</sup> DPC for the post of US/AO. ZOC for original DPC for SOs (Gen) was 20 (8x2 + 4). In the case of 2<sup>nd</sup> DPC, ZOC will be 22 (9x2 + 4). This means 02 more SOs (Gen) will be considered for 2<sup>nd</sup> DPC for the post of US/AO for the Vacancy Year 2015-16. **Eligibility list is at Annexure - S-I.**

DPC for the post of SPO was held for 03 posts. ZOC for original DPC was 10 (3x2 + 4). For 2<sup>nd</sup> DPC, ZOC will be 12 (4x2 + 4). But only 01 more eligible SO (S&P) is available. This means only 01 more SO (S&P) will be considered for 2<sup>nd</sup> DPC for the post of SPO for the Vacancy Year 2015-16. **Eligibility list is at Annexure - S-II.**


