B. The above panel will remain valid for a period of one year from the date of meeting of the DPC i.e. upto 08th September, 2017. The above panel does not confer any right on the empanelled officers for promotion to the posts of US/AO. The appointment to the promoted posts from the above panels will be made subject to the availability of vacancies.

C. The empanelment and consequent appointment on promotion, if any, as US/AO of the junior most officer will be subject to the condition that (i) the officer shall stand reverted to the post of SO (Gen)/PS, as the case may be, if Smt. Parnika Patnaik reverts to CSIR before 31.08.2017 and no vacancy of US/AO is available at the time of reversion of Smt. Patnaik, and (ii) appointment will be on ad-hoc basis and subject to the outcome of sealed cover procedures in one PS and one SO (Gen) or till a subsequent regular vacancy in the post of US/AO arises, whichever is earlier, and (iii) chain reaction of the condition of reversion of junior most DS/COA to the post of US/AO in case of early reversion of Sh. P.K. Ray and non-availability of vacancy of DS/COA. In such eventuality, the junior most US/AO shall stand reverted to the post of SO (Gen)/PS, as the case may be.
