They will be on probation for a period of one year from the date of taking over charge of the post. The probationary period may be extended or curtailed at the discretion of the Competent Authority.

The pay of above officers will be fixed as per provisions of rules. However, they will have an option, to be exercised within one month from the date of taking over charge of the post, for fixation of pay in the new post with effect from the date of appointment in the new post or with effect from the date of increment in the lower post, in terms of the extant provisions of FR-22.
