

The above officials should join their promoted post in their place of posting immediately and in any case within a period of one month from the date of issue of these orders. They will be on probation for a period of one year from the date of taking over charge of the post. The probationary period may be extended or curtailed at the discretion of the Competent Authority.

The pay of above officers in the promoted post will be fixed as per provisions of rules. However, they will have an option, to be exercised within one month from the date of taking over charge of the post, for fixation of pay with effect from the date of taking over charge of the post or with effect from the date of next increment in the lower post, in terms of the extant provisions of FR-22.

The above officials will be entitled for Transfer TA/DA, Joining Time, Joining Time Pay etc. as per the Rules.
