

One post of Driver reserved for OBC (non-technical) in the pay scale of Rs.3050-4590 revised to 5200-20200 (PB-1) with grade pay of Rs.1900/- were advertised vide Advt. No.9/2004 for CSIR H'qrs.

The Screening Committee considered all the applications received and short-listed candidates to be called for driving test/interview by adopting the following criteria with reference to the advertisement:

1. Candidates belonging to OBC.
2. Essential Qualifications and Experience: Class 10th Pass or equivalent with 5 years experience of driving LMV.
3. Age 31 years (28 + 3 years) as on 31.12.2004 with other age relaxation admissible under rules/provision for Ex-Servicemen etc.
4. Candidates who have not submitted copies of OBC Certificate, OBC Certificate in Government of India format and Experience Certificate to be recommended subject to production of same at the time of Driving Test/Interview.
5. Since the last date for receipt of application was 31.12.2004 current validity of driving License as on the date of meeting of Screening Committee (05.11.2007) not to be looked into. However, the short-listed candidates would be required to produce valid Driving License at the time of Driving Test/Interview.
