The observance of the Vigilance Awareness Period should commence with the pledge (copy enclosed) on 25th October, 2010 at 11.00 a.m. This year the main focus of observing Vigilance Awareness Period is "Generation of Awareness and Publicity against Corruption". - Ministry / Department / PSUs / Banks / Organizations are advised to consider the following activities during the Vigilance Awareness Period:-
  - To display banners, posters etc, at prime locations in their office.
  - To organize seminars and invite prominent faculty from the areas to address the participants.
  - To organize competitive dehates / lectures on anti-corruption topics amongst the employees and the student levels in the colleges / schools and to distribute prizes.
  - To issue special journals during the period; and
  - To request the non-government organizations, institution and service associations in the local area to participate in the Vigilance Awareness campaign.
  - To have a dedicated toll-free hotline number to receive complaints against corruption.
- 3. A report about the manner in which the period was observed along with photographs, CDs etc. may be sent to the Central Vigilance Commission by  $15^{th}$  December, 2010, by each organization.
