I am directed to state that in pursuance of Government of India, Department of Expenditure OMs No.7(14)/C&V/2006-1/C dated 14.11.2006 and 9.7.2007 (copies enclosed). DG, CSIR, with the concurrence of FA, has been pleased to decide that in CSIR the following category of employees may be reimbursed telephone charges including mobile/broadband charges up to the ceiling amount mentioned below:-

*As per Ministry of Finance, Department of Expenditure OM dated 9.7.2007 excess expenditure upto 30% of the ceiling amount can be reimbursed to officers of the level of Joint Secretary and above with the concurrence of FA and approval of DG, CSIR subject to submitting a certificate to the effect that excess expenditure incurred was for official purposes and was unavoidable.

2. DG, CSIR has further been pleased to decide that since the internet connection is to promote scientific work and upgradation of skill for scientific and technical staff, telephone/internet facility may be extended to all Scientists Group-IV(1) and IV(2) and Technical officers III(4) and III(5) without the restriction of 25%, and reimbursement may be restricted to Rs.800/-.

3. The above reimbursement will be subject to the following conditions:

- (a) The amount will be reimbursed within the prescribed ceiling on submission of bill/receipt by the concerned officer. There will not be any separate ceiling for land line/mobile/broad band.
- (b) The amount reimbursable will cover land line and/or mobile connection.
- (c) The amount reimbursable is exclusive of all taxes, if any.

- (d) Officers are at liberty to choose any service provider and avail any option for payment within the maximum monthly ceiling.
- (e) It will also include broad band facility or such facilities through which data, voice or image is transferred.
- (f) STD facility on existing telephone may be provided at the residential telephone (in case provided by office), however, there would be no enhancement of ceiling, as prescribed above.
- (g) No Telephone Connection/Instruments (handset/Mobile) would be provided by the office.
- (h) The amount reimbursable will be reduced by Rs.400/-per month, if the officers of the rank of Deputy Secretary/COA and above does not have broadband facility at his/her residence
- (i) Where Internet facility has been provided through office the amount reimbursable will be reduced by Rs.400/- p.m.

4. The expenditure would be met from the Lab. Fund under Budget Head P-04 within the allocated fund. The excess expenditure, if any, may be met out of project fund or Lab. Reserve.

5. A copy of Ministry of Finance, Deptt. Of Expenditure OM No.7(14)/C&V)/2006 dated 10.4.2007 relating to clarifications on various queries and doubts raised on the issue is also enclosed for necessary guidance/compliance.

The above orders will be effective from 1.4.2009.

Subject: Facility of telephone (landline and/or mobile connection) at the residence in respect of entitled categories of Government employees.

The undersigned is directed to refer to this Department's O.M no. 7(8)-E.Coord/82 dated 8.6, 1982 regarding celling on number of calls allowed on official account to officers in the telephone provided at their residence. Since the last CM was issued, there have been many changes in the field of telecommunications and major technological advancements have taken place. This has brought Internet, mobile facilities to the domain of the common people. Many service providers with various schemes have also entered into the market. Further, usage of telecommunication services has proliferated. Therefore, it is imperative that Government officers acopt to the changing trends in communication. In this regard, OM No.7(2)/E:Coord/2005 dated Nov. 23, 2005 on Budget/Expenditure Management; economy measures, rationalization of expenditure and measures for augmentation of revenues, mantions to avail the services of providers other then MTNL/BSNL to curtail the expenditure on telephones and else exhorts that the increased use of information and communication technology should be further encouraged. Though tariff rates have come down, unit duration of calls has decreased and not necessarily resulting into lower call rates. Keeping this in view and the technology available in the field of communication, the existing instructions on the subject have been reviewed. The existing entitlement regarding reimbursement of telephone charges of residential telephones provided to the officers as also on the mobile phones to the entitled officers to the Government of India, and broadband facility at home has been converged into a single package. supersession of OM No.7(8)-E.Coord/82 dt. 8.6.1982; OM No.5(3)/E.Coord/2002 dt. 1.1.2003; OM Nos. 7(3)/E.Goord/2003 dt. 14.1.2004, 26.2:2004 and 5.4.2004, the following decisions have been taken :

The undersigned is directed to refer to this Department's O.M. of even no. dated 14/11/2006, on the subject mentioned above and to say that references have been received from various Departments/Offices seeking enhancement of ceiling amounts and for restoration of the earlier practice of reimbursing these STD calls, made by Officers of the level of Joint Secretary and above as also by Private Secretaries! Officers on Special Duty to the Ministers (who have been provided with residential telephone facility as per norms) from their residential telephones and which are certified as 'Official'. It has been brought to notice that at times, due to unavoidable reasons, the officers concerned have to incur expenditure in excess of the celling amount for making calls which are for bonafide official purposes.

2. The references received on the aforesaid issue have been carefully considered and it has been decided that excess expenditure upto 30 (thirty) percent of the ceiling amount (applicable to the officer) can be reimbursed to officers of the level of Joint Secretary and above and also to Private Secretaries/Officers on Special Duty to the Ministers subject to their submitting a certificate, duty justified, that excess expenditure (upto 30%) would further require the concurrence of the Financial Adviser concerned and secretary/Secretary equivalent officer of the Department/Organisation. In so far as powers in their own cases also: The power to sanction the expenditure shall not be delegated.

3. It has further been decided that the ceiling amount for officers of the rank of Additional Secretary to the Government of India & equivalent shall be Rs.2500/- p.m. Officers of the rank of Joint Secretary to the Government of India and equivalent ranks shall be treated allke for the purpose of reimbursement of telephone facilities. The ceiling amount in respect of this category shall henceforth be Rs 2000/-p.m.

4. All Ministries/Departments may implement this O.M. It is reiterated that no additional funds shall be provided for this purpose and concerned Ministries/Departments/Organizations will have to meet all the expenditure on this account within the existing budget for 'Office Expenses- Telephones'.

The undersigned is directed to refer to the Department's O.M. of even no. dated 14.11.2006, on the subject mentioned above and to state that clarification have been sought by various Ministries/Departments about certain issues relating with the implementation of the aforesaid O.M. like the number of connections qualifying for reimbursement, whether the taxes applicable were to be paid for by the officer or office, whether the entitlement of the residential telephone is to be regulated by this O.M. etc.
