Dear Awam,

As you are aware, Government of India has declared 15th November, the birth anniversary of Bhagwan Birsa Munda, the legendary freedom fighter and tribal leader of the country, as Janjatiya Gaurav Divas to commemorate the contributions of tribal communities in national history and culture, and motivate the coming generations for protecting our cultural heritage and national pride. Ministry of Tribal Affairs has decided to celebrate the 3rd Janjatiya Gaurav Divas 2023 during the period commencing from 15th November, 2023 and leading up to 26th November, 2023 to coincide with the Constitution Day across the country.

2. As Ministries/Departments of Government of India are important stakeholders in ST welfare and development, it is therefore requested to participate in the celebrations of the Janjatiya Gaurav Diwas during this period by undertaking such activities as (i) inauguration or foundation stone laying for infrastructure projects or disbursal of benefits targeting the tribal population; (ii) launch of initiatives/schemes (iii) capacity building activities for sector specific matters oriented towards tribal population (iv) public awareness campaigns in areas with predominantly tribal population on various schemes and other initiatives of your Ministry/Department to enable them to benefits from the scheme; (v) documentation of best practices, success stories, innovative initiatives, digitization and database management (vi) maintenance of disaggregated data of ST beneficiaries of schemes and analysis thereof so as to ensure that the benefits reach them and (vii) any other initiative/activity that the States may find fit to be taken up under the Janjatiya Diwas celebration.

2. I also request to prepare a calendar of events and share the same with us for information. Further, a Nodal Officer from the Ministry/Department may be appointed at the level of Director to coordinate with the MoTA for the celebrations/programmes during JJGD. The nodal officer would be required to attend meetings of the MoTA in this regard, prepare the calendar of activities of your State, implement the same and upload the details thereof in the portal of the MoTA, the access to which shall be furnished to him/her shortly.
