Sir,

As you aware, CSIR is a Central Autonomous Body registered under Societies Registration Act, 1860. The Labs. /Instt. of CSIR have no separate legal entity other than as a constituent unit of CSIR. Despite this fact, it has been noticed that some of the labs./Instts. have got allotted PAN No. in their name which is contrary to the rules on the subject.

Under the circumstances, CSIR can't get refund of Income Tax which is deducted against PAN Number other than the PAN No. AAATC2716R which is allotted to CSIR as a whole. In addition, the Income Tax Authorities are at liberty to impose fine on those Labs. who have got allotted PAN Number in violation of the rules on the subject.

In view of the above, it is requested to instruct the concerned functionaries of the Lab. to quote CSIR PAN Number AAATC2716R wherever Income Tax is deducted, and surrender the PAN Number, if any, got allotted by the laboratory/ Institute without further delay.
