7. The above promotees will be on probation for a period of one year from the date of taking over charge of the post. The probationary period may be extended or curtailed at the discretion of the competent authority.

8. Pay of the above Officers will be fixed under the normal rules. However, they will have the option, to be exercised within one month from the date of taking over charge of the post, for fixation of pay in the new post with effect from the date of promotion to the new post or with effect from the date of increment in the lower post, in terms of the extant provisions of FR-22, under normal rules.

9. The entitlements of Transfer TA, joining time etc. of the promotees shall be as per CSIR rules.

10. All the promotees may be informed that they should join their post in the new place of posting immediately and in any case within a period of one month from the date of issue of this order.

11. The above panels and consequent promotion will be subject to the further orders of Hon'ble Supreme Court in various cases mentioned in DOPT OM No. 36012/11/2016-Estt. (Res-I) {Pt-II} dated 15.06.2018 and/or in any other case related with the matter of reservation and/or reservation in promotion.

12. Directors/Heads of Labs/Instts/CSIR HQ are requested to kindly ensure that the three conditions i.e. (1) No Charge sheet is issued (2) No criminal case is pending (3) officials are not under suspension; do not exist at the time of actual promotion in respect of above officials.

13. If it is found later on that any of the above candidates does not fulfill any of the conditions of eligibility, his/her candidature will be cancelled and no appeal against such cancellation will be entertained.
