### Office Memorandum

Subject: The Transgender Persons (Protection of Rights) Act 2019 and The Transgender Persons (Protection of Rights) Rules, 2020-actions thereof-reg.

The undersigned is directed to refer to subject cited above and to say that the Department of Social Justice and Empowerment is the Nodal Ministry for welfare of Transgender persons. The Transgender Persons (Protection of Rights) Act 2019 has been enacted and The Transgender Persons (Protection of Rights) Rules, 2020 have been notified for mainstreaming of Transgender persons.

- 2. The Transgender Persons (Protection of Rights) Act 2019 makes it mandatory for every establishment to publish equal opportunity and no-discrimination policy for transgender persons.
- 3. It is therefore requested that-
- (a) Transgender persons to be included as eligible beneficiaries in all welfare schemes of your Ministry/Department and their attached/subordinate offices of your Ministry/Department and to maintain the transgender persons related data.
- (b) To publish and display equal opportunity and no-discrimination policy in occupation, livelihood, recruitment, promotion, education

etc.for transgender persons.

- (c) To organize sensitization programmes on The Transgender Persons (Protection of Rights) Act 2019 and The Transgender Persons (Protection of Rights) Rules, 2020 at your Ministry/Department and attached/sub-ordinate offices of your Ministry/Department.
- (d) A "Complaint Officer" to be nominated in your Ministry/Department and attached/sub-ordinate offices of your Ministry/Department to deal with grievance of transgender persons.
- (e) A "Nodal Officer" to be nominated in your Ministry/Department as one- contact-point for providing information on transgender persons.
- 4. This Ministry will be glad to extend support to your Ministry/Department in implementation of above mentioned requests. Efforts of your Ministry/Department for building an inclusive society will go a long way in mainstreaming the transgender persons.
- 5. This issues with the approval of competent authority.
