Sub: Scheme of Financial Assistance to CSIR employees for meeting medical expenses - reg.

Sir/Madam,

I am directed to state that the DG, CSIR has constituted a Committee under the Chairmanship of Dr Ranjana Agarwal, Director, CSIR- NIScPR, to review the Financial Assistance Scheme. The recommendations of the Committee were considered by the Governing Body, CSIR in its 203rd meeting held on 06.10.2023 and has approved that:

- (i) The Financial Assistance scheme may be continued for a period of three years. Further, the scheme may be extended beyond three years by the Director General, CSIR in consultation with FA, CSIR.
- (ii) The scope of the Scheme will now cover any major medical illness/procedure without any restriction on the type of disease/ailment.
 - (iii) The reimbursement limit under the scheme has been revised as under:

	Existing limit	Revised limit
For Self	75% of Expense incurred over and above the admissible amount to maximum of Rs. 2,00,000/-	75% of Expense incurred over and above the admissible amount to maximum of Rs. 5,00,000/-
For dependent Family Member	50% subject to maximum of Rs. 1,00,000/-	60% subject to maximum of Rs. 3,00,000/-

- 3. You are, therefore, requested that the CSIR-Financial Assistance Scheme may kindly be brought to the notice of all the employees for more awareness of the Scheme.
