**Sub.:** Minimum Floor price for minimum wage based manpower Outsourcing Service – clarification reg.

Sir/ Madam,

I am directed to refer CSIR letter of even number dated 14.08.2023 on the above subject matter and to state that a reference has been received from a Lab seeking approval for award of the tender to the lowest bidder (L1) where the service charges quoted is more than 3.85%.

- 2. In this regard, the matter has been examined in consultation with IFD, CSIR and it is clarified that the instructions issued vide DoE OM No. 6/1/2023-PPD dated 06.01.2023 have only provided prescribing minimum service range from 3.85% to 7% in the tender document and there is no bar in these instructions on the award of the tender to the lowest bidder if he has quoted service charges more than the service charges prescribed as minimum service charges.
- 4. Therefore, the approval of CSIR-HQs as stipulated in letter dated 14.08.2023, is required only in cases where the 'minimum service charge' in the tender documents is being fixed more than the prescribed 3.85%.
- 4. You are, therefore, requested to kindly bring the above clarification to the notice of all the concerned for information and necessary action.

#### OFFICE MEMORANDUM

Subject: Proposal on Minimum Floor price for minimum wage based Manpower Outsourcing Service.

The undersigned is directed to refer to Government e-Marketplace (GeM) OM No. 9/JS&ACEO/2022 dated 22.12.2022 regarding the subject cited above and to say as under:

- a. The minimum service charges in the procurement of Manpower Outsourcing Service may be fixed as 3.85% (3% profit plus transaction charges, which are 0.85% at present) as proposed by GeM.
- b. The procuring entities can also fix the service charge above 3.85% with proper justification on file, wherever required. However, such charges should not exceed 7% (including transaction charges) in any case.
- c. Least Cost System (LCS) may be considered for procurement, wherever appropriate, especially in high value cases.
