Dear Director,

Voluntary Vehicle Fleet Modernization Program (V-VMP) is an important flagship program of the Govt under which vehicles of 15 Years or more are required to be scrapped on priority. Unfortunately, the labs/Instt/Units have not accorded the importance that this task deserves.

2. I am constrained to bring to your notice that except for a few labs viz CBRI, CDRI, CEERI, CGCRI, CLRI, CMC, HRDC, IGIB, IHBT, IICB, IICT, IITR, IMMT, NCL, NGRI, NIIST the rest of the Labs/Instts/Units have not replied to the CSIR letter dated 13.03.2024 (copy enclosed) seeking the current status of scrapping.

Subject: Scrapping of vehicles "Fit for Scrapping/Condemnation"- Status report up to 31<sup>st</sup> March 2024.

(Kind Attention Sr. COAs/COAs/AOs)

महोदया/Madam / महोदय/Sir,

You are aware that Vehicles which are 15 (or more) years old are eligible for **Scrapping**. Likewise, Vehicles which have fulfilled the prescribed years of life and distance run are eligible for **Mature Condemnation**. Vehicles either not fulfilling the criteria for scrapping or Mature Condemnation can also be considered for **Pre-mature Condemnation**, if the condition of the vehicle is beyond economic running / repair. In all these three cases i.e. **Scrapping, Mature Condemnation** and **Pre-mature Condemnation**, the vehicles are to be **scrapped** through RVSFs as per the detailed procedure notified.

2. Vide communications on the above subject matter vide letters dated 10.01.2023, 10.02.2023, 17.08.2023 and 16.10.2023, all were requested to expedite scrapping of all eligible vehicles on priority, under

intimation to Headquarters. However, the progress in this regard is not very encouraging. Even reports are not forthcoming regularly.

3. All Labs/Insttts/Units are, accordingly, requested to furnish the progress of scrapping up to 31<sup>st</sup> March 2024 in the format enclosed in respect of all vehicles declared fit for scrapping or mature condemnation or pre-mature condemnation. The report may be emailed at [spo.hqrs@csir.res.in](mailto:spo.hqrs@csir.res.in) positively on or before 5<sup>th</sup> April 2024.
