विषय : सुरक्षा सहायक/वॉच एवं वार्ड सहायक और सुरक्षा अधिकारी के पद के लिए सशस्त बलों और अर्धसैनिक बलों के सेवारत कर्मियों के लिए आयु में छूट पर स्पष्टीकरण के संबंध में।

महोदय / महोदया,

मुझे यह कहने का निदेश हुआ है कि प्रयोगशालाओं/संस्थानों से सुरक्षा सहायक/वॉच एवं वार्ड सहायक और सुरक्षा अधिकारी के पद हेतु सशस्त्र बलों और अर्धसैनिक बलों के सेवारत कर्मियों के लिए आयु सीमा में छूट पर स्पष्टीकरण मांगने हेतु संदर्भ प्राप्त हुए हैं। इस संदर्भ में, आप कृपया सीएसआईआर के दिनांक 30 जनवरी, 2003 के पत्र संख्या 17/92/8/2000-EII का संदर्भ लें जिसमें सुरक्षा अधिकारी और सुरक्षा सहायक/वॉच एवं वार्ड सहायक और सुरक्षा अधिकारी के पद की भर्ती के लिए आयु सीमा में छूट के प्रावधान निम्नानुसार निर्धारित हैं:

"Relaxation in age limit for Ex-serviceman/SC/ST/OBC candidates, as per prescribed GOI from time to time will continue to be operative."

2. सक्षम प्राधिकारी द्वारा मामले की जांच की गई है, और यह स्पष्ट किया गया है कि सुरक्षा अधिकारी और सुरक्षा सहायक/वॉच एवं वार्ड सहायक के पद के लिए आयु सीमा में छूट केवल समय-समय पर संशोधित भूतपूर्व सैनिक (केंद्रीय सिविल सेवा और पद में पुनर्नियोजन) नियम, 1979 के नियम 2 (ग) के तहत परिभाषित 'भूतपूर्व सैनिक' के लिए उपलब्ध है।यह सशस्त बलों (उन सेवारत व्यक्तियों को छोड़कर जिन्हें नियोक्ता द्वारा उनकी पेंशन अर्जित करने के बाद कार्यमुक्त किया जा रहा है) और अर्धसैनिक बलों के सेवारत कार्मिकों पर लागू नहीं है।

Subject:-Career development of staff belonging to isolated categories of posts regarding.

Sir,

I am directed to state that based on the recommendations of the Committee constituted by the DG, CSIR to review the entire scheme for career development of staff belonging to isolated category, the Governing Body at its 155th meeting held on 19.12.2002 has approved categorization of isolated categories of posts in the following three Groups with different scales of pay in each Group for recruitment and career progression of the staff within the same Group. The specific entry level qualifications for different Groups have also been prescribed to ensure uniformity in qualifications and experience. It has further been decided that fresh appointment in different Groups will be made only at the entry level scale:

1. Group-C posts

 Relaxation in age limit for Ex-servicemen/SC/ST/OBC candidates, as prescribed by the GOI from time to time will continue to be operative.

As per the existing provisions incumbents in the pre-revised scale of Rs.1500-2000 may be considered for next higher grade of Rs.2000-2250(prerevised) after they have been held up for one year at the maximum of the grade. In view of revision of pay scales, the G.B. has approved promotion of incumbents belonging to isolated category of posts in the pay scale of Rs.12000-16500(prerevised Rs.1500-2000) on completion of 8 years of service, or after having been held up for one year at the maximum of the grade whichever is earlier, on merit, based on the recommendations of the DPC, which shall invite the candidates for personal discussions and with the approval of Member (Finance). However, for other categories of staff the existing system of 11 years residency period will continue.

With the rationalization of the entry level scales and qualifications under different categories, on vacation of post(s) by incumbent(s) at the higher level on retirement/resignation etc. the post(s) would revert to the new/revised scale of pay and not in the scale in which the incumbent(s) vacating the post(s) was/were recruited. It may, therefore, be ensured that in a situation where the existing post happens to be in lower/higher scales than the revised scales mentioned above the matter may be referred to CSIR with full details before filling up the post. The existing employees holding lower grades other than the approved grades will continue to hold the same as personal to them and may be considered for placement in the next approved grade in the relevant groups only on completion of prescribed residency period.

The above decisions will be effective from the date of modification. You are requested to kindly take further action for recruitment and promotion of incumbents holding isolated categories of posts accordingly.
