

# Council of Scientific and Industrial Research – St. Petersburg State University Joint Research Funding Call Guidance- 2024

#### Introduction

We are happy to announce that the Council of Scientific and Industrial Research (CSIR) and St. Petersburg State University(SPBU) Joint Research Projects Program for Funding research proposals is now open. Researchers from CSIR and SPBU are invited to submit applications that target to develop new research engagements between CSIR & SPBU.

We intend to fund upto 5 projects. Successful proposals will be awarded up to Rs. ₹ 5,00,000/- for CSIR applicants and ₱ 500,000 Rubles for SPBU applicants per project.

We welcome applications from all disciplines of Physical Sciences, Chemical Sciences, Biological Sciences, Engineering Sciences and Information Sciences; in particular, we strongly encourage applications to develop new research partnerships or new research ideas in the fields of physics, chemistry, nanotechnology, material sciences, renewable energy, computer sciences, artificial intelligence and Medicine.

Funding will be available until the end of December 2024 and must be used within this timeframe.

#### **Applications**

The following documents should be submitted:

- 1. Application form as per **Annexure I**
- 2. Concurrence duly signed by the PIs from both sides as per *Annexure II* (for CSIR applicant)
- 3. CV of the project leader and list of the key project members
- 4. Recommendation of Director of the CSIR Institute as per *Annexure III* (for CSIR applicant)

The enclosed application form must be used for submissions. Applications should:

- demonstrate strategic alignment
- include a project activity plan (details see below)
- include a project output plan (details see below)
- include a breakup of the requested budget (details see below)
- describe the expected impact of proposed activities and explain the potential impact or wider benefits to society
- demonstrate project sustainability such as describing future funding plans
- justify each party's contribution to the project

#### **Eligibility and Submission Procedure**

- Applications are open to all CSIR and SPBU regular staff members. PhD students are not eligible to apply for funding through this scheme.
- Any Project must have one CSIR and one SPbU project leader, the project leaders should be full-time Scientist/ Professors at its institutions. Post-doctors cannot apply individually but can join as co-researchers.
- Single application by proposal partners, typed in English, in a maximum of four sides of A4 for SPbU applicant. The same would be submitted online by CSIR applicant through <a href="CSIR's International Cooperation Management System(ICMS)">CSIR's International Cooperation Management System(ICMS)</a> available on CSIR website.





• Please submit applications through the CSIR Website (www.csir.res.in) on CSIR's International Cooperation Management System(ICMS) and in duplicate by email to <a href="Svetlana">Svetlana</a> <a href="Chaplygina">Chaplygina</a> (SPBU).

#### Project activity plan

Applications must outline how this funding will support activities with CSIR and SPBU partners including but not limit to:

- Preliminary data collection and analysis for developing a research proposal for external funding calls
- Visiting/Hosting a colleague to discuss a research proposal and/or a publication or other form of impact outputs
- Co-organizing and co-delivering workshops seminars
- Delivering public lectures

#### Project output plan

Expected outputs from activities must include a second year plan plus a minimum of two of the following:

- PhD mobility
- Submission of a significant external funding application
- Publications in top-tier journals
- Policy, industry or civic engagement

#### **Duration of Exchange Visits**

The duration of the visit shall not exceed 30 (Thirty) days per project.

#### **Budget of projects**

This includes consumables for obtaining pilot data, costs in travel and subsistence, costs associated with networking events, administrative support and access to technical support, etc.

As agreed in the CSIR-SPbU Agreement for support of Joint Research Projects Program, the costs of exchange of experts, scientists and other specialists, where ever applicable, will be covered on the following basis:

- The sending Party shall meet all costs connected with the roundtrip international travel up to the host institute, overseas travel insurance and emergency health insurance for its research team members visiting the partner institute.
- The receiving Party can assist in the accommodation at the University Residence Hall/Institute Guest Houses on a fee basis.
- The duration of the visit shall not exceed 30 days per project.
- In case of Networking meetings/workshops/conferences/seminars, the entire expenditure towards the implementation of the workshop/meeting including the expenditure on hospitality (in-kind towards accommodation, food, internal transportation etc) will be borne by the proposing institute with funding from the corresponding Party.

The budget will not include staff salaries, costs of standalone events that are not part of the activity plan, or activities that would have taken place regardless (for instance, connected to an existing conference).

#### CSIR would provide the following to its applicants (limiting to INR 5,00,000/-):

• Mobility costs: travel costs for the visiting Indian experts up to the host institute/nearest airport including visa fee and insurance, and the living expenses for the visiting Russian researchers;





- Publication, bilateral conference/workshop organization, and contingency costs
- Research cost such as for equipment and consumable, shall be met by the CSIR Institute through existing project grants.

#### Assessment

Applications will be assessed by a Panel constituted by the Vice President/Rector/Director General at both institutions. The following evaluation criteria would be followed for selection:

- Clearly formulated goals of the Project,
- Information on envisaged synergies between the Parties,
- Level of concreteness of future joint research project, incl. timeframe and information on funding programs and steps for developing a joint proposal,
- Compatibility with CSIR /SPbU research profiles, such as interdisciplinary nature, excellence of project leaders, wide scope of different fields/labs represented in the proposed Project.

#### Academic match making

Given the collaborative nature of this funding call, interested parties are encouraged to familiarize themselves with colleagues from the Partner institution to identify potential collaborators.

Either <u>Anand Mohit (CSIR)</u> or <u>Svetlana Chaplygina</u>, <u>SPBU</u> may be connected, if required to facilitate an introduction with the potential collaborators.

• Outcomes communicated: 1st July

• Activity takes place: July – December 2024

• Completion of activity and report submitted – 10 January 2025

#### **Application Terms and Conditions**

- 1. Applications will not be accepted unless signed by applicants from both institutions who can use electronic signatures.
- 2. This funding should not be used for one off activities.
- 3. The same person can only apply for one project as project leader.
- 4. Should any activity involve international travel, this should be planned following government advice in India and the Russia. Any funds used for travel (e.g. flights) must be booked in accordance with SPBU's Travel and Expenses Policy and Procedures and as per CSIR Foreign Deputation Guidelines.
- 5. Activity associated with successful bids must be completed **by 31st Dec 2024** to ensure financial reconciliation in line with the end of CSIR and SPBU financial year.
- 6. Successful applicants will be asked to submit a report outlining the activity outcomes, impacts of the activities, detailed expenditure and next steps for the newly established collaboration e.g. grant proposal once activity has concluded.
- 7. Unspent funds will be reclaimed/should be submitted back before the end of the 2024-2025 financial year.
- 8. Successful applicants will be asked to share details of any media profile generated; published blogs or social media as well as sharing photographs for inclusion in future promotional materials.
- 9. All other terms and conditions (Article 9: IP and Confidentiality, Article 8: governing laws and Dispute resolution, etc) specified in the CSIR-SPbU Joint Seed Money Agreement would apply to all applications/activities under this call detailed below for ready reference.

## Article 8 & 9 of the CSIR-SPbU Joint Seed Money Agreement-2024

#### ARTICLE 8. Dispute Settlement and Governing Law

- 8.1. For conditions of the Joint Research Fund not covered by this Agreement, or for problems that arise during the course of the Joint Research Fund, both Parties agree to refrain from unilateral action and to consult and negotiate mutually acceptable decisions in writing.
- 8.2. Any dispute between the Parties arising out of the interpretation or implementation of this Agreement shall be settled amicably through consultation or negotiation between the Parties to the dispute. In case of inability to solve the dispute amicably, it will be settled through diplomatic channels by forming a coordination committee for this purpose consisting of the equal number of representatives of both sides. The decision of this coordination committee will be binding upon all the Parties.

#### ARTICLE 9. Additional Provisions including Confidentiality and Intellectual Property Rights

- 9.1. As long as the idea of this Agreement is maintained, the Administrative Coordinators can amend technical provisions of this Agreement through mutual written consent, especially on dates and selection procedures.
- 9.2 As a result of the cooperation activities developed under this Agreement, products of commercial value and / or intellectual property rights generated, these shall be governed by the applicable national legislations of the Parties, and by the international conventions in the matter of which the Russian Federation and the Republic of India are party to.
- 9.3 Each Party shall retain exclusive rights in respect of all Intellectual Property Rights owned by it on the date of this Agreement and nothing in this Agreement shall be construed as granting any right, title, interest or license to or in respect of the Intellectual Property Rights of either Party.
- 9.4 The Parties agree that any research publications and scientific papers arising out of this Agreement shall be jointly published in reputed scientific and technical journals in accordance with laws, regulations and rules of the Parties. The use of name, logo and/or official emblem of the Parties on any publication, document and/or paper will require prior written permission of both Parties. This may ensure that the official emblem and logo are not misused.
- 9.5 Any scientific and technical information, not protected by the intellectual property rights, which may be obtained as a result of this Agreement, excluding information which may not be disclosed in view of national security or commercial or industrial considerations, may be appropriately used by both Parties in accordance with the procedures agreed upon by the Parties. In exchanging and disseminating such information, both Parties shall take into account existing legal provisions, the rights of third parties and international obligations.
- 9.6 Subject to national legislation and multilateral agreements and memorandums in force in both countries, the Parties shall adopt appropriate measures to protect the intellectual property rights arising from the implementation of this Agreement.
- 9.7 If any Intellectual Property (IP) is generated under this Agreement, the Parties shall enter into a CSIR Ref. No: E63976 AB-CSIR/24/2024-ISTAD-CSIR HQ dated 04/05/2024





separate agreement that will specifically provide for ownership, management and commercialization of rights to such IP, in line with rules and regulations of each Party including other multilateral agreements to which countries of both Parties are party to.

9.8 Science and technology related information obtained in course of cooperation within the framework of this Agreement, except for confidential commercial information, can be shared among the scientific community elsewhere, through mutual consent of the Parties in writing and in accordance with the international obligations of each country of the Parties, existing national legislations of each Party, and also in accordance with the regulations of the collaborating organizations and institutions of the Parties. 9.9 Each Party shall guarantee the confidentiality of all documents, data or any information exchanged, received or provided by the other Party under this Agreement. Such confidential, documents, data, information shall not used for any other purposes than this agreement and shall not be disclosed or shared with third party without the prior written consent of the Party that provided the documents, data, or information. The provisions of this Article shall remain in force notwithstanding the termination of this Agreement, under the terms established by the applicable national legislations of the Parties.


