Sub: Commencement of First (1<sup>st</sup>) Session of the Eighteenth (18<sup>th</sup>) Lok Sabha and Two Hundred and Sixty-Four (264<sup>th</sup>) Session of the Rajya Sabha- 2024.

Tuesday, 25<sup>th</sup> June 2024 – Oath or affirmation


Wednesday, 26<sup>th</sup> June 2024 – Oath or affirmation and Election of Speaker

Thursday, 27<sup>th</sup> June 2024 –PRESIDENT'S ADDRESS TO BOTH THE HOUSES OF PARLIAEMENT ASSEMBLED TOGETHER AT 11.00 AM IN THE LOK SABHA CHAMBER, PARLIAMENT HOUSE, NEW DELHI (Govt. Business to follow Half-an-hour after the Address)

The timing of sittings in Lok Sabha and Rajya Sabha during Session, 2024 will be 11.00 AM to 01.00 PM and 02.00 PM to 06.00 PM.

There will be no Question Hour during the 1<sup>st</sup> Session of the 18<sup>th</sup> Lok Sabha and no Question Hour, Zero Hour and Private Members' Business during the 264<sup>th</sup> Session of Rajya Sabha. Only Government business shall be conducted in Lok Sabha and Rajya Sabha during Session, 2024.

During the above Parliament Session, all Divisional Head and Officers of CSIR are requested to remain available for attending to Parliamentary work. Any other work will not be accorded higher priority unless specific approval for doing so has been obtained from DG, CSIR/ Secretary, DSIR. They are also requested not to proceed on leave or tour during Parliament Session without seeking approval of the DG, CSIR/ Secretary, DSIR.
