विषय/Sub: Counting of Special Pay of Rs. 2000/-(before 2006) and Rs. 4000/- (after 2006) for the purpose of reckoning of Pension/Pensionary Benefits to the retired Scientists of CSIR - fixation of pension in r/o Chief Scientists retired between 01.01.2016 and 30.06.2017 and clarification thereof.

महोदय/Sir / महोदया/Madam,

Kind reference is invited to CSIR letter of even number dated 05.09.2023 regarding counting of Special Pay of Rs. 2000/-(before 2006) and Rs. 4000/-(after 2006) for the purpose of reckoning of Pension/Pensionary Benefits to the retired Scientists of CSIR and the methodology thereof. Reference has been received from the Labs/Institutes regarding counting of Special Pay towards reckoning pension/pensionary benefits to Scientists who retired between 01.01.2016 and 30.06.2017.

In this context, I am directed to state that the matter has been examined in consultation with FA, CSIR and it is clarified that the following methodology may be adopted for counting of Special Pay towards reckoning pension/pensionary benefits to Chief Scientists who retired during the period from 01.01.2016 to 30.06.2017.

Methodology:

"Special Pay may not be merged in the last Basic Pay. Once Pension is computed on the basis of last pay drawn, 50% of the quantum of Special Pay as drawn by the employee on the date of retirement (Rs. 2000/- and Rs. 4000/- as the case may be) may be added to the Pension so fixed. In case of revision of Pension after Pay Commission in terms of respective guidelines of DoPPW, the Special Pay will not be taken into consideration. However, once Pension is revised, 50% of the Special Pay as available to the employee on the date of retirement shall be added to such revised Pension".
