Sub: Creation, Revival, Continuation, Conversion, Transfer, Up-gradation, Downgradation and Abolition of Administrative Posts – clarification thereof – reg.

Sir/Madam,

Kind attention is invited to CSIR letter of even number dated 25.01.2024 whereby Department of Expenditure OM No. 7(1)/E.Coord-I/2017(Part.III) dated 04.01.2024 on the above subject has been endorsed in CSIR. As per the provisions of *ibid* DoE OM dated 04.01.2024, all posts which are lying vacant for more than 5 years from the date of creation or the date of falling vacant shall stand abolished.

- 2. In this regard, it is stated that with CSIR vide letter dated 16.07.2020 notified the Sanctioned Strength of Administrative Cadres i.e. Gen./F&A/S&P/Steno. in respect of CSIR-Labs./Instts. after Restructuring and Review of Administrative Cadres in CSIR.
- 3. With reference to these administrative posts, CSIR had requested Department of Expenditure to confirm that the administrative posts are live and the period of 5 years is to be reckoned from notification of revised sanctioned strength of restructured administrative cadres to CSIR Labs./Instts. i.e. 16.07.2020.
- 4. Now, Department of Expenditure vide ID Note No.12(1)/DSIR-CSIR/2024/E.Coord.I dated 01.07.2024 has informed that "The approved posts in cadre restructuring notified in July, 2020 will remain live for a 5 year period i.e. till July, 2025."
- 5. Accordingly, you are requested to fill all the vacant posts of these Administrative Cadres immediately in accordance with the CSIR-ASRP Rules, 2020. Appointing Authority and Sr.DS/Sr.CoA/DS/CoA/US/AO of the concerned Lab./Instt./Hqrs shall be held responsible for allowing the posts to fall in the category of 'deemed abolished posts' due to their lying vacant for more than five years.
