**OFFICE MEMORANDUM**

**Sub: Transfer & Posting of ASOs on promotion, through LDCE-2024– reg.**

**Ref: CSIR OM No.3-2(b)/LDCE-2024-E-I(RC)/5 dated 23.07.2024**

Consequent upon the transfer and posting orders issued vide CSIR OM No.3-2(b)/LDCE-2024-E-I(RC)/5 dated 23.07.2024, CSIR HQ has received numerous requests and representations for retention as ASO and changes in the place of posting from various individuals and Directors of labs/institutes.

2. All the requests have been carefully considered in light of the vacancy positions in the labs/institutes, as well as the overall organizational interest. It was found that, in most cases, vacancies under DTQ are not available in the concerned labs/institutes. However, considering the available vacancies under DTQ and the organizational interest, requests for retention or change of posting have been approved in the following cases:

They shall stand relieved from IICB with effect from 30.11.2024 (AN) and shall be deemed to be under the administrative control of the Director/Laboratory where they are posted, as per the order dated 23.07.2024, effective from 01.12.2024 (FN).
