High Standard VVIP Catering Services are required at CSIR-Science Centre, Lodi Garden Gate No. 2, KK Birla Lane, Lodi Estate, New Delhi for meeting/conference purposes and other places such as CSIR Hqrs Rafi Marg, National Media Centre, Raisina Road, Prathvi BHawan, Lodhi road, NPL, Pusa, INSA, ITO etc.
- 2. The Contractor shall provide catering services as per the following menu(s) in the dining hall / lawns of the CSIR-Science Centre.

At CSIR Science Centre, VVIP buffet lunch/dinner will be served as per given menu. The Contractor shall ensure requisite quantity, quality and efficient service in proper uniform in its dining hall/lawn.

4. The tender has to be accompanied by an Earnest Money Deposit of Rs. 50,000/- (Fifty Thousand only) in the form of Demand Draft in favour of Joint Secretary (Admin.), New Delhi from any scheduled commercial Bank. If the successful tenderer declines to act on the offer made by the CSIR and/or withdraw/amend their quotations after opening of tenders, the EMD shall stand forfeited without any notice to the tenderer and no claim on this account shall be entertained. The EMD of unsuccessful tenderers shall be returned/refunded after finalization of the contract.

- 5. A Performance Bank Guaranty of Rs. 1,40,000 (One lakh forty thousand only) shall have to be deposited by the successful tenderer in the form of FDR of any scheduled commercial Bank in favour of "Joint Secretary (Admin.), New Delhi" for the period of contract. The performance security will be forfeited for breach of the any of terms/conditions of our tender and if it is found at any time during the contract period that the services provided by the firm are poor/defective/unsatisfactory. The decision of the CSIR in this regard shall be final and binding on the firm.
- 6. Tenure of contract will be for two (02) years and 2nd year will be continued only after the satisfactory performance of the contractor in first year of contract.
- 7. The Contractor will report to the Manager of CSIR-Science Centre, Lodi Garden Gate No. 2, KK Birla Lane, Lodi Estate, New Delhi.
- 8. The Contractor will provide his own staff for catering/serving purpose in the CSIR Science Centre, including uniforms to his staff.
- 9. The Contractor will have to bring his own kitchen utensils, Bone China crockery and glassware etc. These also shall have to be well maintained. Old/used crockery in unhealthy state shall not be used.
- **10.** The Contractor shall provide good quality paper napkins during service of meals.
- 11. No stale or left over food will be served to the guests/consumers.
- **12.** The Contractor is expected to use good quality and standard brands of cooking oils and Agmark masalas. Contractor is also expected to use groceries (provisions) of standard quality. He may note that only fresh vegetables will be used and served.
- **13.** The Staff deployed by the Contractor in the kitchen should wear proper uniform and should be medically fit.
- **14.** The Contractor shall not use cracked, chipped and stained crockery. The Contractor shall replace all chipped, cracked, stained and broken crockery items immediately at his own cost.
- **15.** Liquor and tobacco or other intoxicants will not be served to the guests/consumers at CSIR Science Centre.
- 16. A suggestion register shall be kept at the Guest House for registering suggestions with regard to all/any aspect of the food including services provided by the Contractor and the contractor shall take appropriate remedial steps in this regards under intimation to CSIR.

- 17. Joint Secretary (Admn.) CSIR reserves the right to check/have tested from certified agency any time at the cost of Contractor the raw materials used for breakfasts, lunches, diner, tea/coffee etc. and the items served in CSIR Science Centre. Financial losses and other damages caused to CSIR on account of substandard food served at CSIR Science Centre are liable to be recovered from the Contractor in an appropriate manner. The designated officials of CSIR are entitled to inspect the premises at any time to ensure its bonafide use, hygienic and cleanliness and quality of the ingredients used.
- **18.** Joint secretary (Admin) CSIR reserves the right to terminate the contract at any time even without assigning any reason thereof.
- 19. A pre bid conference will be held at CSIR Science Centre on 11/11/2024 at 12.00 Hrs. Interested vendors are requested to visit CSIR-Science Centre, Lodi Garden Gate No. 2, KK Birla Lane, Lodi Estate, New Delhi to inspect the location and understand the requirement, before submitting the bid. You may submit your quires, if any, at email: so gen@csir.res.in, 02 days before the pre bid meeting date. The quires raised by the venders shall be attended and replied properly, in case of any changes, corrigendum will be issued and accordingly you may submit your tender.
- 20. <u>Technical evaluation of bid will be done only for those bidders who will attend</u> pre bid conference on the decided date and time.
- 21. Work will be awarded to only one firm confirming the standard quality and on overall lowest quotation basis.
- **22.** Successful bidder have to execute a necessary agreement with CSIR on a Rs. 100 non-judicial stamp paper.

B. COMMENCEMENT AND TERMINATION

That this contract may be terminated on any of the following contingencies:

- a) On the expiry of the contract period as stated above.
- **b)** By giving one month's notice by CSIR on account of:
 - i) Committing breach by the Contractor of any of the terms and conditions of this contract.
 - ii) On assigning the contract or any part thereof to any sub-Contractor by the Contractor without written permission of the CSIR.
 - iii) On Contractor being declared insolvent by competent Court of Law.

During the notice period, in the situation contemplated above, the contractor shall keep on discharging his duties as before till the expiry of notice period.

C. ARBITRATION CLAUSE

1. In case any dispute or difference arises between parties regarding terms & condition of the contract for providing items listed at point No. A.3 above, so matter shall be referred to Delhi International Arbitration Centre (DIAC), Delhi High Court, New Delhi for Arbitration. The award of the Arbitrator shall be final and binding on both parties and the arbitration proceeding shall take place under the Arbitration Conciliation (Amendment) Act, 2015 or any other statutory modification thereof.

D. TERMS OF PAYMENT

- 1. No payment shall be made in advance nor any loan from any bank or financial institution recommended on the basis of the order of award of work.
- 2. The contractor shall submit the bill after providing services within a week for sanction of the amount of bill and passing the bill for payment.
- Online payment for the catering services at CSIR Science Centre, Lodi Garden, Gate No. 2, Lodi Estate, New Delhi will be made directly through NEFT/RTGS by the CSIR Hqrs to the Contractor against proper certification of receipts by the Manager, Science Centre.
- 4. The term payment mentioned in this Para includes all types of payment due to the service provider arising on account of this contract.
