Since the said notification, following developments took place:

- a. Sh. Rakesh Bidalia, Sr. Deputy Financial Advisor, CSIR-HQ vide his application dated 03.10.2024 sought voluntary retirement from Council Service w.e.f. 31.01.2025 under FR 56K. The same has been approved by DG, CSIR and is notified vide this office OM No. 3-8(272)7/95-E.I dated 18.11.2024.
