

I am directed to state that the provisions of Model Code of Conduct are enforced from the date of announcement of election schedule by the Election Commission and remain in operation till the completion of election process.

2. Now, that the results in respect of General Elections to State Legislative Assemblies of Jharkhand & Maharashtra, 2024 and Bye-elections in Parliamentary/ Assembly Constituencies of various States have been declared by the concerned Returning Officers, the Model Code of Conduct has ceased to be in operation with immediate effect.
