Sub : Review DPCs for implementing Reservation in promotion(DPC) to Persons with Benchmark Disabilities (PwBDs) in Lowest rung of Group 'A' i.e US & equivalent in light of DoPT DOPT OM No.36012/1/2020-Estt(Res-II) dated 28.12.2023 endorsed vide CSIR letter No.5-1(39)/2008—PD dated 26.02.2024

1. The review DPCs will not be conducted for the vacancy years of the respective cadres where the eligible PwBD candidates are either nil or has been promoted on merit in the concerned DPCs for the purpose of being an infructuous exercise.

2. The eligible PwBD candidates who has already been assessed by the concerned DPC will not assessed again and only those candidates who were not assessed earlier will now be assessed by the Review DPCs.
