1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

3. Payment

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

Verification of Original documents: During the technical evaluation of bids, be asked to submit the ori ginal of all documents, scanned copies of those were such technical bid. The vehicles whose details provid ed in bid may be asked for inspection at CCI premises during the technical evaluation, failing which his/her bids will liable to be terminated summarily.

2. **Financial Standing**: Solvency Certificate for **Rs. 2 crore** issued by any bank for current financial ye ar to attached with bid and original certificate to be submitted with buyer on opening of technical bid. Certificate to be issued after publication of bid.

- 3. The bidder must have requisite license, permits, registration etc. from appropriate authority to carry out transport service. Document to this effect to be attached with document.
- 4. The bidder should submit latest GST Challan and payment receipts for last six months.
- 5. Bidders have to upload the notarized scanned copy of the declaration on letter stating that the bidder h as not been black listed by any Ministry/Department/Organizations. The hard copy shall be submitted before bid end date.

7. Further, in case of reduction in fuel price, the reduction in rates shall applicable.

8. The contract can be terminated at any time on account of unsatisfactory services upon review of pe rformance by the Competent Authority in CSIR Hqrs. The unsatisfactory service shall mean and includ e non-compliance and non-fulfillment of any of the contractual obligations by the service provider or p oor performance or violation of any of the terms and conditions of the tender/contract and failure on th e service provider's part to correct the discrepancies/shortcomings, brought to its notice in writing by t he CSIR Hqrs' Official.

9. By virtue of this agreement, no relationship of employees and employer will be created between the drivers deployed and CSIR. It will be the sole responsibility of the service provider to pay salary and ot her perks to its drivers and no complaints by any of its drivers in this regard will be entertained by CSI R Hqrs.

10. If after award of the contract, the successful bidder (L-1) fails to provide required number of vehicles/taxies, the contract is then liable to be terminated alongwith forfeiture of performance securit y deposit and other consequential actions such as blacklisting of the firm etc.

11. If after award of the contract, the successful bidder (L-1) fails to provide required number of vehicles/ta xies, the contract is then liable to be terminated alongwith forfeiture of performance security deposit and o ther consequential actions such as blacklisting of the firm etc.

12. The agreement can be terminated earlier than the duration of contract by giving one month's written notice by CSIR and three months' notice by the Serv ice Provider without assigning any reason and the decision of the Competent Au

thority, CSIR shall be binding on the service provider. No claims for compensatio n for the loss of revenue due to such decision shall be entertained.

13. At any stage no vehicle older than three years should be deployed during the contract period.

14. The quoted rates will be all inclusive and no other charges will be paid extra except parking charges & toll taxes.

15. There will be no dead mileage. The kilo-meterage for the purpose of "**vehicl e run**" and "**hours of duty**" shall be reckoned from pickup point and drop poin t. Pickup point shall always be the CSIR Hqrs, while the drop point shall be the p oint at which vehicle has been released by the user.

16. No mileage will be allowed to drivers for lunch/breakfast or for filling of petr ol/diesel/CNG etc. The firm will ensure that the fuel tank of vehicles provided is completely filled up before deputing the vehicle for duty.

17.The drivers provided by the firm should be well mannered, courteous and polite to the Officers wit h whom they are attached alongwith vehicle. They should be well acquainted with routes of Delhi/NCR are a, punctual with valid driving licenses and they should have neat and clean uniforms with name badges. T he drivers should not smoke or drink while on duty and should not play cards etc. during waiting time. The firms will ensure that vehicles and drivers of the dedicated vehicles are not normally changed. Frequent ch anges of vehicles and drivers will not be permitted.

18. All expenses will have to be borne by the firm in case of breakdown of the ve hicle supplied. Immediate replacement of the breakdown vehicle will have to b e provided.

19. In case a vehicle is requisitioned and the same does not reach at the appointed time and place, CSIR will be free to call another vehicle from the open market and the expenses on this account will be deducted from the pending bills/se curity etc.
