Sub.: Amendment to 'CSIR Scientists Recruitment & Assessment Promotion (CSRAP) Rules, 2001- reg.

In exercise of the powers conferred in the Rule 9 of CSIR Scientists Recruitment & Assessment Promotion (CSRAP) Rules, 2001, the Competent Authority on the recommendation of Recruitment and Assessment Board, CSIR has approved the amendment in CSRAP Rules, 2001, as under:

<p>Rule 7.6.6</p> <p>Scientists recommended by the Committee as 'Fit' for Promotion' shall be so promoted from the due date of eligibility for assessment. Scientists who are found 'Not fit for Promotion' will be considered after a gap of one year if they are again recommended by the Internal Screening Committee.</p> <p>The pay fixation on promotion shall be as per normal pay fixation rules issued by the GOI from time to time.</p>	<p>Rule 7.6.6</p> <p>Scientists recommended by the Committee as 'Fit' for Promotion' shall be so promoted from the due date of eligibility for assessment. Scientists who are found 'Not fit for Promotion' will be considered after a gap of one year if they are again recommended by the Internal Screening Committee.</p> <p><u>Notwithstanding anything contained in the CSRAP Rules, 2001, in case of scientists who are having due date of Assessment between 01.04.2025 and 31.12.2025 and are found "fit for promotion" by the Assessment Committee, shall be promoted from the due date notionally, however, actual monetary benefit in their case shall accrue from the date on which the Scientist assumes the charge of the promoted grade/post.</u></p> <p>The pay fixation on promotion shall be as per normal pay fixation rules issued by the GOI from time to time.</p>

2. In addition, the competent Authority has also approved, as under:

"Notwithstanding anything contained in the CSRAP Rules, 2001, in case of scientists who have due date for assessment promotion between 01.10.2025 and 31.12.2025 under the CSRAP Rules, 2001, PMS up to

year 2024-25 are to be considered for determining the minimum threshold."
