**Sub:** 2<sup>nd</sup> DPC for the post of Sr.DFA/Sr. COFA for VY 2025 and Changes in the Details of Vacancies and Eligibility Lists etc. for consideration for Promotion to the post of Sr. DFA/Sr. COFA for the Vacancy Year 2026-reg.

Kind attention is invited towards this office notification of even number dated 08.09.25 vide which tentative details of Vacancies and Eligibility Lists etc. for consideration for Promotion to Group 'A' Common Cadre Posts for the Vacancy Year 2026 was notified.

2. In the said notification it was assumed that all the officers empaneled vide DPC for VY 2025 will join the promoted post on or before 31.12.2025.

3. However, one or more of the following circumstances has arisen in respect of one COFA/DFA empaneled for the post of Sr.COFA/Sr.DFA for VY 2025:

- (i) Government servant under suspension;
- (ii) Government servant in respect of whom a charge sheet has been issued and the disciplinary proceedings are pending; and
- (iii) Government servant in respect of whom prosecution for a criminal charge is pending.


4. Therefore in light of the DOPT OM DOPT OM No.22011/4/91 -Estt.(A) dated 14.09.1992, the recommendation in respect of the said officer will be considered as if his case had been placed in a sealed cover by the DPC and therefore, the promotion shall not be effected.

5. Thus, a vacancy for the post of Sr. DFA for the Vacancy year 2025 will remain unfilled. Accordingly, a 2<sup>nd</sup> DPC will be conducted for the post of Sr. DFA for the VY 2025 vide which the DPC is expected to recommend a candidate in officiating basis from the candidates who were next in line and have already been assessed by the DPC for VY 2025 but were not recommended for the want of vacancy. The same will be conducted on 18th Nov 2025.

6. Apart from the above, there would be changes in the list of eligible Dy. FA/COFA falling in ZOC for the post of Sr. DFA/Sr.COFA for VY 2026 notified vide this office notification No. 3-3(b)/2025(VY-26)-E. I dated 08.09.25. The revised details are mentioned at Annexure-I.

7. The other details and terms & conditions will be the same as per this office notification of even number dated 08.09.2025 vide which tentative Details of Vacancies and Eligibility Lists etc. for consideration for Promotion to Group 'A' Common Cadre Posts for the Vacancy Year 2026 were notified.

8. It is reiterated that the ZOCs are dependent, inter alia, upon the resultant vacancies. Therefore, ZOCs for these posts may undergo a change depending upon the results of respective higher posts.
