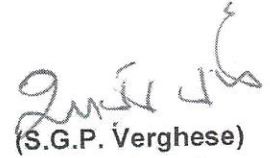

I am directed to state that the provisions of Model Code of Conduct are enforced from the date of announcement of election schedule by the Election Commission and remain in operation till the completion of election process.

Now, that the results in respect of General Election to the Legislative Assembly of Bihar, 2025 and Bye-elections in Assembly Constituencies of Jammu & Kashmir (27-Budgam AC & 77-Nagrota AC), Rajasthan (193-Anta AC), Jharkhand (45-Ghatsila (ST) AC), Telangana (61-Jubilee Hills AC), Punjab (21-Tarn Taran AC), Mizoram (2-Dampa(ST) AC) and Odisha (71-Nuapada AC) have been declared by the concerned Returning Officers, the Model Code of Conduct has ceased to be in operation with immediate effect.
