OFFICE MEMORANDUM

Sub: Entitlement of recipients of civilian awards for attending the Awards Presentation Ceremony at New Delhi.

In supersession of this Ministry's OM No. 1/27/2002-Public dated 19.12.2002 on the subject mentioned above, the undersigned is directed to say that the recipients of 'Bharat Ratna', 'Padma Vibhushan', 'Padma Bhushan', and 'Padma Shri' awards and civilian recipients of Ashoka Chakra series of Gallantry awards, viz. 'Ashoka Chakra', 'Kirti Chakra' and 'Shaurya Chakra' will be entitled to the following, while attending the Awards Presentation Ceremony at New Delhi:-

a) Reimbursement of Travel Expenses

The Ministry of Home Affairs would reimburse the cost of travel to Delhi and back. The recipients have the option to travel by Air or by Rail (AC First Class) or by road (mileage restricted to AC First Class Rail fare).

~~In addition, taxi fare incurred on travel from the place of residence to the airport/railway station; from the airport/railway station at Delhi to the place of stay at Delhi; and on the same lines for the return journey is also reimbursable.~~

b) Out of Pocket Allowance

The recipients will be entitled to a lump-sum 'out of pocket allowance' @ Rs. 1000/-.

c) Guests

- i) Recipients of 'Bharat Ratna' and 'Ashoka Chakra' are entitled to bring two guests at Government expense.
- ii) Recipients of 'Kirti Chakra' and 'Shaurya Chakra' are entitled to bring one guest at Government expense.
- iii) ~~Recipients of 'Padma Vibhushan', 'Padma Bhushan', and 'Padma Shri' are entitled to bring one guest at Government expense.~~
- iv) Reimbursement of travel expenses in respect of recipients traveling from abroad (foreigners, NRIs/PIOs) will be made from their respective country to New Delhi & back. They are, however, not entitled to bring any guest at Government expense.

d) Boarding and Lodging:

Arrangements for the board and lodging of the recipients and their guests (as per entitlement indicated in previous paragraph) will be made by the Government at Hotel Ashok for six nights in the case of 'Ashoka Chakra' awardees and for four nights in the case of 'Shakti Chakra', 'Kirti Chakra' and 'Padma' awardees, unless they choose to make their own arrangements. (The period of board and lodging covers the day of rehearsal and the day of the Awards Presentation Ceremony and the day preceding the day of rehearsal and the day following the day of the Awards Presentation Ceremony.)

2. The expenditure involved in respect of the above will be debitable to Major Head '2052' - Secretariat - General Services - 00.090 - Secretariat (Minor Head) 03-Ministry of Home Affairs 03.00.50 - Other charges under the Grant Number of the concerned financial year.

3. The controlling officer for the purpose of drawing advance for reimbursement of travel expenses will be Under Secretary (Cash), Ministry of Home Affairs.
